In order to testify, <u>individuals must sign up in advance</u>, providing sufficient information to allow the Clerk to properly record their testimony in the official record of the City Council. Hearing procedures call for presentation by the applicant, submission of information from City staff, and is followed by public testimony. The rules for testifying include the following: applicant will have 15 minutes to present their project; testimony by the public will be limited to 3 minutes per person. Testimony at public hearings on applications brought forth from the Planning & Zoning Commission can be used to reaffirm previous testimony.

Chief Bunderson- Nothing for tonight

City/P&Z Administrator Craig Eckles- Thanked the staff for covering for him last week. He is grateful to be alive and well. He had great doctors. He welcomed Brian back home, and stated there are several individuals dealing with family issues. Craig stated he thought the MVMPO public outreach at RCFD went well. He thanked The Mayor, council, Brian, and the Chief for being there. Theres a ton to the MVMPO, and he hopes to start seeing some action and funding in the next year. We are in standings for the state of Idaho. He is in high hopes of getting some help for HWY 30 and the 3400 intersection. He is going to keep fighting for it. The people doing the interview got it. Craig thanked Brian for working with Jackie Fry on the utilities. Craig stated there are some people kicking dirt and possibly sub-divide on the property East of 1st Federal Plaza. Therse are some big hitters. Could be around 5 million just in infrastructure. There have been several people look at it over the years. Some if its residential South of Paintbrush. Les Schwab is looking good. Signs are up. They had to do a few more things to comply with ITD, and now moving forward. Centennial Sub-division is done. In Sage Meadow all lots are sold. Olsen Farms Phase I is all sold. The property North of the Taylors was bought by 3-Emeralds, it is not in city limits. We should anticipate developments later on down the road. Ten more Building Permits were issues on the Patterson Farms Sub-division this week. Phase I is going fast. Another public facility to come, and will be a great asset to the city. It is not residential.

Public Engineer Brian Reed- Stated the all of the PI stations that the city is responsible for are online. Brian stated they will be doing some work over at the Kimberly Meadows site, and water will be off for a brief time. Arbor Day will be held at the Main City Park this Thursday at 9:00am. He hopes to see everyone there. The RV Dump is open. Les Schwab is wrapping up as Craig said and he hope to see them open in the next few weeks. The Chip Seal Bid opening is this Friday April 25, 2025 at 10:00. He stated he believes there has been one packet picked up.
